A RESOLUTION OF THE CITY OF FRIEND, NEBRASKA, AUTHORIZING THE SALE OF CERTAIN PERSONAL PROPERTY AND TO ESTABLISH A SALE DATE.

WHEREAS, the City of Friend is the owner of certain miscellaneous personal property which is determined to be surplus property; namely the following:

1981 International Tandem Pay Star F5050 and,

WHEREAS, the best interests of the City would be served by selling this personal property; and,

WHEREAS, the City Council wishes to designate the terms and procedures by which this personal property will be sold;

NOW, THEREFORE, BE IT RESOLVED:

1. The City Council hereby authorizes the sale of certain miscellaneous personal property of the City of Friend. It further finds that the total value of this property may be greater than \$5,000.

2. The City Clerk is authorized to publish in one or more legal newspapers published in or of general circulation in the City and post a notice of sale of this miscellaneous personal property, indicating the terms thereof. Said notice shall be published once at least 7 days prior to the sale of the property. The Clerk shall further post notice of the sale and the terms thereof in three prominent places within the City. The sale date is established as April 18, 2007. The sale shall be by sealed bids delivered to City Hall on or prior to the sale date.

The personal property shall be sold for cash, to be paid for in full on the sale date. All property is offered for sale as is, where is, with no representations or warranties of any nature. The City of Friend reserves the right to reject any or all bids made or tendered. The confirmation of sale by the passage of an ordinance by the City Council is a condition of the sale.


