

RESOLUTION NO. 05-02

WHEREAS, Section 5-205 of the Municipal Code of the City of Friend, Nebraska directs that the City Council may by resolution provide for the placing of signs or signals in any street under the jurisdiction of the City for the purpose of regulating traffic thereon, and

WHEREAS, it is deemed necessary to place such sign(s) at the appropriate location for the protection of the public;

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF FRIEND, NEBRASKA as follows:

A stop sign is hereby designated to be erected, maintained and rules to be enforced, in accordance with Nebraska State Statute (60-6,148; 60-6,121; 60-682) on the west side of the south exit, entering 2nd Street, in the alley between Maple Street and Chestnut Street. It shall also be designated that a sign stating, "WATCH FOR PEDESTRIANS" be placed in a manner near or adjacent to the same. It shall be unlawful for any driver approaching the intersection and pedestrian crossing, except when directed by a peace officer or traffic control signal, to proceed in a manner deemed a violation of Nebraska State Statute.

Councilperson Fricke moved the adoption of said Resolution. Councilperson Weber seconded the motion. Upon vote the following Councilpersons voted aye, Tuttle, Schrock, Weber, Fricke. Nays, none. The Mayor declared Resolution 05-02 adopted.

-I would recommend the removal of the current "No Parking" w/arrow sign from the south side of 2nd between the Hospital and the Friendship terrace parking and the addition of (1) "No Parking Any Time" sign

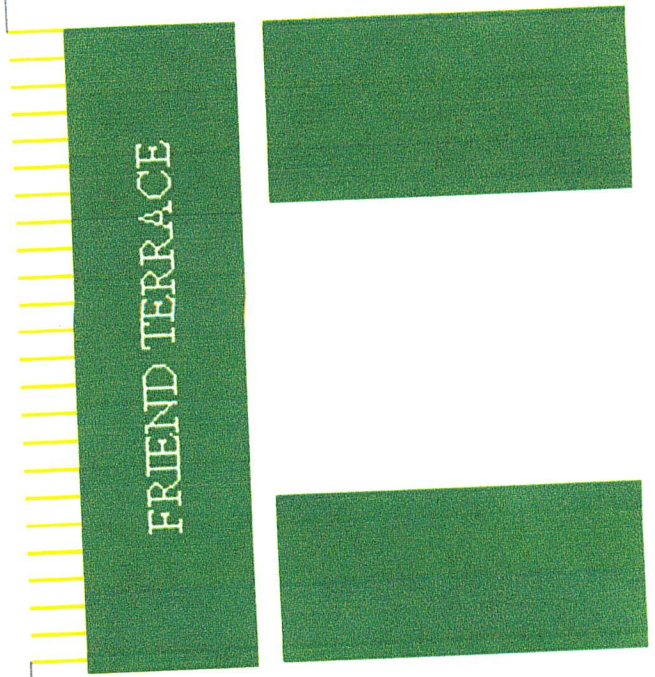
SYCAMORE ST

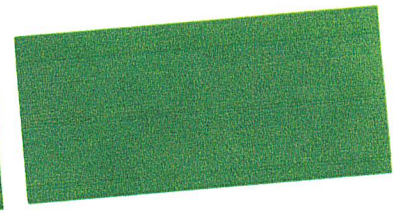
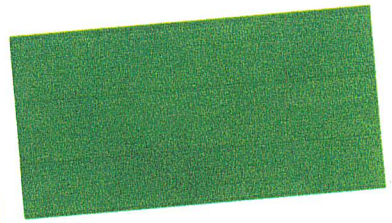

No parking of any vehicle of any type shall be allowed on either side of 2nd Street between Spring Street and Sycamore Street, with exception to the existing permanent parking allotted for Warren Memorial Hospital and Friendship Terrace. Signs stating, "NO PARKING ANYTIME" shall be erected and located in the necessary manner to so identify and designate this area.
