

RESOLUTION 95-6

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA, APPROVING THE APPLICATION OF THE FARMERS UNION COOP COMPANY OF FRIEND, FOR A SPECIAL DESIGNATED PERMIT UNDER THE NEBRASKA LIQUOR CONTROL ACT, TO DISPENSE BEER AT THE BUSINESS APPRECIATION SUPPER TO BE HELD ON SEPTEMBER 16, 1995, IN THE CITY PARK OF FRIEND, NEBRASKA, THE SAID SPECIAL DESIGNATED BEER PERMIT TO BE LIMITED TO THE FENCED OFF AREA INSIDE THE TENNIS COURT IN THE CITY PARK BETWEEN MAPLE STREET AND CHESTNUT STREET, BETWEEN THE HOURS OF 5:00 O'CLOCK P.M. ON SATURDAY, SEPTEMBER 16, 1995, TO 12:00 O'CLOCK MIDNIGHT ON SEPTEMBER 16, 1995, PURSUANT TO THE MUNICIPAL CODE OF THE CITY OF FRIEND, AND THE NEBRASKA LIQUOR CONTROL ACT.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA, that they hereby approve the application of the Farmers Union Coop Company of Friend, for a special designated beer permit for the fenced off area inside the tennis court in the City Park between Maple Street and Chestnut Street, between the hours of 5:00 o'clock P.M. on September 16, 1995 to 12:00 o'clock midnight on September 16, 1995, pursuant to the municipal code of the City of Friend, and the Nebraska Liquor Control Act.
