A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA, AMENDING THE TRAFFIC REGULATIONS RESOLUTION, SO AS TO PROVIDE THAT NO PARKING BE PERMITTED UPON THE WEST SIDE OF CHESTNUT STREET, BETWEEN FIRST STREET, WHICH IS HIGHWAY #6 and 10TH STREET, WHICH IS THE STREET BORDERING THE NORTH SIDE OF THE PARK, FOR THE REASON THAT THE SAME CONSTITUTES A MAIN THOROUGHFARE BETWEEN THE CITY PARK AND RECREATION AREAS, INCLUDING THE BALL FIELD AND THE FOOTBALL/TRACK FIELD, AND THEREFORE IS, BY VIRTUE OF THE NARROWNESS OF THE STREET, VIRTUALLY A ONE LANE STREET IF PARKING IS PERMITTED ON BOTH SIDES.

IT IS HEREBY RESOLVED by the Mayor and City Council that the Traffic Regulations Resolution be amended to provide as follows:

- 1. No parking is hereafter permitted upon the West side of Chestnut Street, between First Street, which is Highway #6 and 10th Street, which is the street bordering the north side of the park.
- 2. Violation of this traffic regulation shall be punishable by a fine of up to \$100.00 and payment of court costs.
- 3. This Resolution shall be construed to be a part of all previous traffic regulation resolutions in the City of Friend.
