A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA GRANTING APPROVAL AND GIVING LEGAL EFFECT TO RULE NO. 008.02 OF THE NEBRASKA DEPARTMENT OF ROADS PURSUANT TO SECTION 39-6179 AND SECTION 39-6180, GRANTING A 20% WEIGHT TOLERANCE TO LOADED GARBAGE DISPOSAL TRUCKS OPERATING IN AND THROUGH THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA, AS FOLLOWS:

- 1. Pursuant to Rule 008.02 of the State of Nebraska Department of Roads, the Mayor and City Council approve the granting to garbage haulers a continuing permit for the movement of garbage trucks with an enclosed body and a compacting mechanism designed and used exclusively for collection and transportation of garbage/refuse on all roads and streets in and through the City of Friend, Saline County, Nebraska.
- 2. Such truck and load may exceed the maximum axle load permitted by law by no more than 20% on only one tandem axle or one group of axles when the vehicle is laden with garbage or refuse and when the vehicle is within the maximum gross load as permitted by State Statute 39-6179 and 39-6180; said permit shall commence upon passage and publication by this Resolution and shall continue until such time as it is repealed by the Mayor and City Council.
- 3. The City Clerk is directed to send a certified copy of this Resolution to the Nebraska Department of Roads, Lincoln, Nebraska, after its passage and publication according to law.
